Community Forum – 26 February 2025

Development Updates - February 2025

District Centre Enabling Works, including Sainsbury's

· Completed:

- Last month we reported that Phase 1 of the spine road and drainage has been completed, including the new entrance to Sainsbury's.
- The 1st phase of utilities has progressed well this month with electricity and gas now laid. We have a date in March for water to be laid, finishing off the Phase 1 services.
- $\circ~$ The 2nd phase of earthworks, roads and drainage are all progressing well.
- We'd like to thank everyone affected by the recent increase in site traffic for your patience. The contractors have been reminded to be considerate, particularly when driving and parking on local roads.

In Progress:

- Sainsbury's are back on-site and are now well underway with their new service road and groundworks for the new store.
- In March, the 2nd phase of earthworks, roads and drainage will continue with further utilities being laid down the spine road to service the new homes, shops and community facilities.

Upcoming:

 We are close to completing the sale of the development parcels for the new homes and shops and look forward to sharing more details in the next newsletter!

Sports Facilities

We remain on programme with the design and tender process of the sports facilities.
 Demolition of the existing pavilion is currently planned for May-June ahead of construction starting in September.

We are working to accelerate the refurbishment of the tennis courts and currently plan to commence works in April.

Open Spaces

- Nightingale Fields Allotments: Many have noted the recent flooding on the
 allotments following the recent wet weather. We have inspected the site with a
 drainage engineer who has designed us a strategy to resolve this over the coming
 weeks we'll be re-grading the land and digging a land drain to address this,
 alongside the planting and seeding works ready for handover of the allotments to
 Arborfield & Newland Parish Council in April.
- **V2 Green Corridor:** As per our previous update, aside from a few remedial works, the majority of works have been completed and come Spring, the seeding can be finished, ready to open up this section of the Green Corridor to the community.
- Head of Lake: As per our previous update, we are working closely with the Council's highways department to finalise plans and have agreed on a solution in principle. Our engineer is preparing designs to agree the specification for adoption.

Parcel Sales Updates

- New Homes & Shops: Another housebuilder has been selected to deliver the homes and commercial space in the District Centre in line with the plans approved.
 We anticipate being able to share further details next month, with work to begin in spring 2025.
- Pub Operator: As per our previous update, negotiations are paused as the
 operator requires the completion of the surrounding buildings, High Street, and
 village green before purchasing the land. We expect to re-commence these later this
 year.
- Moat House/Parcel S: Our planning application to convert the Grade II listed Moat
 House into four apartments has been approved. This will be taken forward by
 Berkshire-based Hicks Homes as part of a small development of eight or nine
 homes.
